

GUIDELINES FOR ADMISSION INTO CLASS- XI IN
BIJU PATTNAIK ADARSHA VIDYALAYA (BPAV), PALLUR HILLS, KANISI, GANJAM
FOR THE ACADEMIC YEAR 2025-26

Part-1: Definitions

Unless the context suggest otherwise, the definition of the following terms used in these guidelines would be as below:

- I. "BPAV" means BIJU PATTNAIK ADARSHA VIDYALAYA.
- II. "ST" means Scheduled Tribes.
- III. "PVTG" means Particularly Vulnerable Tribal Group.
- IV. "SC" means Scheduled Caste.

Part -2: General Guidelines

- I. There is no age restriction for admission to Class XI provided the student is seeking admission in the year of passing Class X Examination.

2.2 General Eligibility Criteria

The candidates belonging to the reserved categories as mentioned at table 2.3, who have successfully passed Class-X examination are eligible to apply for admission in Class-XI.

2.3 Reservation of seats in Class-XI in BPAV

| Total Seats | | ST | SC | PVTG |
|--------------|------------|------------|-----------|----------|
| Boys | 60 | 50 | 6 | 4 |
| Girls | 60 | 50 | 6 | 4 |
| Total | 120 | 100 | 12 | 8 |

Note:

1. Four seats each are earmarked exclusively for PVTG Boys and Girls. The PVTG students can also avail the seats meant in ST category on their merit. If the seats earmarked for PVTG Boys and Girls are not filled up due to non-availability of PVTG candidates, these seats may be filled up by ST category students.

2.4 Selection of students

- i. No entrance test shall be conducted for admission to Class-XI. The candidates will be selected on the basis of marks/CGPA secured by them in Class-X in CBSE/State board exam.
- ii. All students who have passed Class-X examination 2025 from BPAV and applied for admission to Class-XI will be selected/ allowed to take admission in Class-XI.
- iii. The students other than the students as mentioned at point-ii above belonging to ST, SC & PVTG community who have passed Class-X examination and applied for admission in Class-XI may be considered for admission subject to availability of vacant seats in the respective category on the basis of merit list to be prepared by BPAV. Separate merit list shall be prepared accordingly.

- iv. The district level selection committee for selection of students shall be constituted under the Chairmanship of the District Collector with other members as mentioned below.
 - a. Inspector of Schools (SSD)
 - b. District Welfare Officer
 - c. Principal of the School

2.5 Subject to be made available in Science stream

- I. English
- II. Physics
- III. Chemistry
- IV. Mathematics
- V. Biology
- VI. Computer Science

2.6 Admission of students of State Boards/ICSE in Class XI in BPAV

The students of State Boards/ICSE may be considered for admission in class XI, if vacancies are available.

Part-3 : Documents

The candidates who are provisionally selected for admission will have to submit the requisite documents, as demanded by the BPAV at the time of admission for verification. However, a list of documents is mentioned as below:-

- i. Date of birth certificate issued by the authority competent to register births. The original certificate of date of birth should be returned to the parent after verification.
- ii. Aadhar Number / Card

(It is pertinent to mention here that none of the child is to be denied admission on non-submission of Aadhar number. For the students having no Aadhar number, the authorities of BPAV shall facilitate the student in procurement of Aadhar number.)

- iii. Domicile / Reservation Category certificate issued by Competent Authority within the state of Odisha.
- iv. Disability certificate, if applicable.
- v. Report of Medical check-up of the Provisionally Selected Students is to be carried out by BPAV.
- vi. Transfer Certificate / School Leaving Certificate from the previous School.
